

Agreement to and Understanding of Your Mini Session
With Model/Client Release Form

Our "Mini Session" special pricing is \$60 for 20 minutes and is for (1) "subject" only per mini session. ("Subject" will be 1 person or 2 people in the same shot; not each individually separate. If you want each individual separate you will be required to pay an extra \$50) This will be on location in Portage or Lake Station or at our new studio located downstairs in The Miller School Shops- 665 South Lake Street, Miller, IN

The session will include (3) *standard* fully edited digital images with a right to print form. (*Your digital images will be professionally edited for color balance, clarity, exposure, contrast, removal of any distracting elements.*) Images received are at the discretion of the photographer. You will receive your images within 1 week after the shoot. No prints are included in this offer if shot ON LOCATION, although if you would like HSP to have your images printed, you will incur an extra charge of \$15 per sheet. Any mini session at the studio will receive 3 sheets of prints.

A \$30 initial payment for service is required to hold your date; the remainder due at the shoot. All payments to be made through cash app or cash. You will have to sign a client release form to have your photo shoot.

Our mini sessions include a clause stating that you, the client, will not alter any of HSP digital images in any way; including but not limited to: cropping, cropping out watermark, removing watermark, or using filters or any other effects of any kind.

You will receive a full rights to print document stating such to take to your printing lab if you are printing your photos yourself.

Henry Schultz Photography reserves all rights to use any digital or print image for advertising or photography publishing, either on-line or in print, without your consent or reimbursement to you for such under the United States and International Copyright Law.

Client, and Legal Guardian if necessary, understands and agrees that Photographer may have cords, light stands, and other gear at the location. Client will hold Photographer harmless for any damage, personal injury, or loss caused by tripping over or otherwise being injured from this equipment. Client, and Legal Guardian if necessary, further agrees to hold Photographer harmless for any personal injury which may occur as the Client poses or works with Photographer. Client, and Legal Guardian if necessary, understands and agrees that Client, or their Legal Guardian, is responsible for determining if a pose or location is safe and has the right to refuse the pose or location if they feel uncomfortable or unsafe in anyway. By posing in any way, with or without a photography prop, Client and/or their Legal Guardian are acknowledging that they are in agreement with the pose and will not hold HSP liable in any way if Client is injured while posing.

Client, or their Legal Guardian, agrees and understands that the quality of a photograph or likeness of the Client is entirely subjective. Photographer will strive to present photos in a workmanlike manner but is not required to cater to specific aesthetic preferences of the Client or their Legal Guardian.
